SPLKA reports that the 2012 season at the WRLS was positive with over 3900 adults and over 850 children resulting in about \$18,000.00 in Revenue, along with an additional \$2352.00 from gift shop sales. Communication from the Muskegon County Sheriff's office was received informing the townships of low number of jail workers available for volunteer cleanup which has resulted in our increased wage for seasonal part time help. Supervisor St. Amour spoke to Parks & Recreation Chairwoman Shields about the possibility of re-finishing the picnic tables. The P&R Commission favors this re-finishing and will make the necessary budget amendments at their November meeting. The MCRC Annual Roadkill Banquet is Thursday, November 1, 2012.
