She also stated that the State of Michigan will be sending out absentee voter ballot applications to all registered voters not on the Fruitland Township’s permanent AV list in which the clerk mailed those last Thursday. Treasurer Pachman announced she will be mailing out summer tax bills by month end. An insert will be included with the tax bills for information on the Senior Resource Millage and Parks & Recreation Commission update. Supervisor Jeske updated the Board on the monies distributed out to the senior residents totaling \$3,900.00 with an additional \$2,500.00 to the Senior Center. She received an email from Tom Moore of the White Lake Community Education that a monthly senior membership to the Whitehall Athletic Vikings Center will be \$20.00. In-office discussions thought that one monthly check could be issued to Whitehall District Schools with a listing of the residents’ names for it to be applied against. It is still currently closed due to the COVID-19 Pandemic.
