A lot of our filming will be focused around the bridge area in front of Duck Lake State Park.

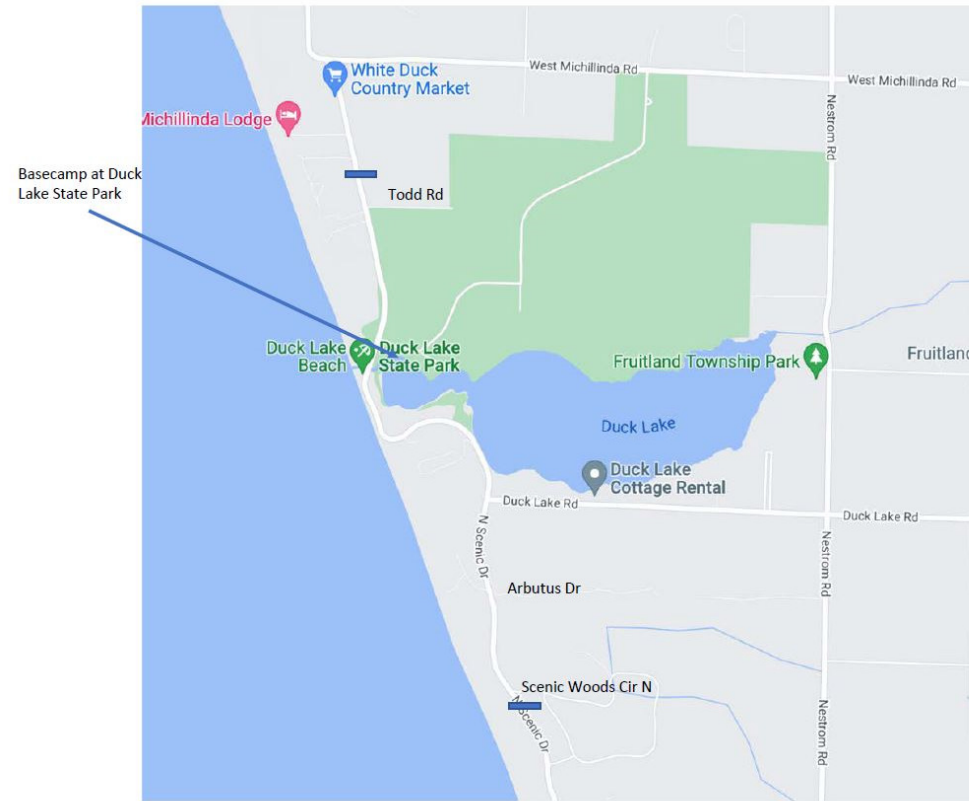
The shoot consists of filming (2) picture vehicles (pickup trucks) driving along a coastal road as well as a few shots of the vehicles parked.

Time permitting if possible we would also like to grab a few shots on S Shore dr between Bluff rd and N Scenic Dr.

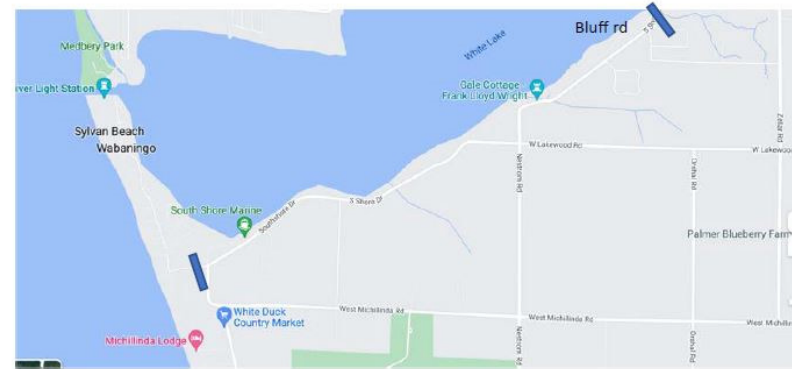
The shoot consists of filming (3) picture vehicles (pickup trucks) driving along a coastal road as well as a few shots of the vehicle(s) parked.

We are planning to film on the road with our camera car as well as drone.

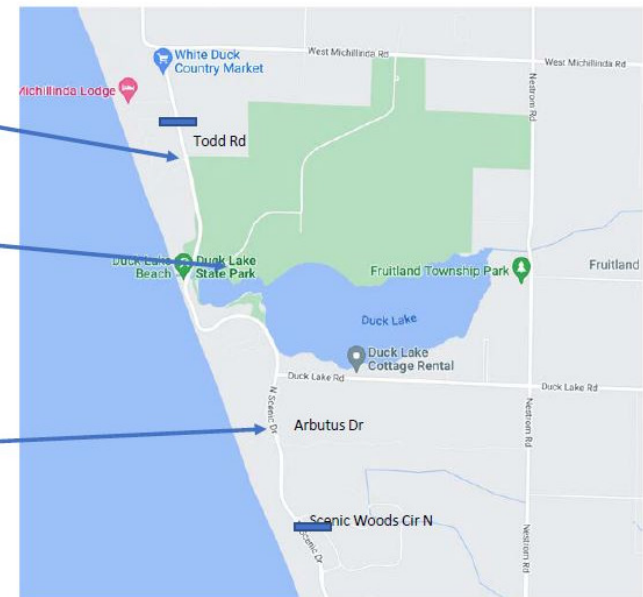
The (3) picture vehicle will be towing items like a boat or RV.
