Chairperson Roesler explained that a few months ago an amendment was made to change the number of children allowed for Family Child Care Home and Group Child Care Homes. The State requirements say a group child care home shall be issued a special land use permit if it meets all standards.

Consensus of Commissioners is the applicant meets the requirements of Article XIV, SPECIAL LAND USES, SECTION 14.04, SPECIAL LAND USE SPECIFIC REQUIREMENTS M. Group and commercial child care homes and facilities with the stipulation that a fence must be done before begins operation.

Applicant advises it is just her and one employee so there will be no parking issues. She has a total of nine families, twelve children total. Day children are gone by 6:30 p.m. She does have one 3rd shift child that comes from 8:00 p.m. to 8:00 a.m.

After brief discussion consensus was to waive the requirement of not exceeding 16 hours in a 24-hour period. This will allow the applicant to continue with the 3^{rd} shift child.

Discussion was held on number of vehicles that would be in/out daily, consensus is that nine cars would not be considered excessive.

Motion by Commissioner Warner, second from Commissioner Holman, *ADOPTED*, to recommend approval to the Township Board of Trustees the special land use permit for 61-06-444-000-0016-00, 5249 Bittersweet, for the operation of a Group Child Care Home, excepting the "do not exceed 16 hours of operation during a 24-hour period" requirement.
