Trustee Graham shared that a representative doing Broadband research told her that Fruitland Township will likely see broadband coverage increase soon. Clerk Fagan shared that approximately 25% of voters showed up to vote at the May 2 election. The MAISD proposal passed while WHSD proposal did not. She shared that the Senior Millage allocation has been received for this year and the vouchers should be available in June. Clerk Fagan has been working with BS&A for the payroll module, but full transition will not happen until October. Supervisor Marcinkowski reminded the Board that our term is up in 2024 and encouraged members to consider running for Supervisor.
