Motion by Clerk Fagan, second by Trustee Holman, **ADOPTED**, to approve the Supervisor's request to establish a CAC to investigate a road millage for Fruitland Township.

PUBLIC COMMENT -

Chief McCarthy, WLFA – Stressed the importance of the White Lake Fire Authority Articles of Incorporation and thanked the Board for doing their due diligence.

Explained that the reason behind requesting all seven members be added as signors happened after a specific incident in the past that delayed the signing of a paycheck.

Jessica Cook, County Commissioner for District 6 – Muskegon County will be receiving funding in response to the Opioid crisis and discussed how decisions will be made with that spending. Also discussed the early voting changes and the County's plan to handle early voting.

BOARD COMMENTS/DISCUSSION – Clerk Fagan reported that TextMyGov will go live this week and an e-news will be sent with the information. She discussed a request from a paranormal investigator to investigate the WRLS and the Curator's statement as to why she does not want the investigation done. The Board agreed with her comments. Clerk Fagan announced a Good

Neighbor Community Meal at the White Lake Community Library on September 28. She plans to attend but all Board members and the public are invited but must register. White Lake Fire Authority is also having an open house on September 28th from 5-8pm. Clerk Fagan stated she will have more information about the County's early voting plan in October. Clerk Fagan announced that September 19, 2023 is the 30 year anniversary of the current Fruitland Township Hall. She has some newspaper articles, pictures, and other items on display in the meeting room and will leave them out until the end of the month.
