The commissioners discussed the idea and said it would be something that would need much discussion and consideration.

The commissioners also agreed that the idea of lighting the pavilions needs to happen.

5. Spark grant

Chairman Murray stated that the commission will know at the end of September whether or not they were awarded any money from the Spark grant. He added that only 7% of those that applied will get funding. The commissioners agreed that they could go after other grants if they don't get any of the Spark grant, adding that the flush restrooms need to be a priority.
