David Rice 4047 Nestrom, Recommended looking into the Grand River Band before signing a letter of support. Will be working on the Blueberry Festival 10K and will work with Clerk Fagan if it moves forward.

BOARD COMMENTS/DISCUSSION – Trustee Lundell commented that her meetings with Supervisor Marcinkowski regarding the agricultural overlay do not violate the Open Meetings Act due to it only being two members that are not making decisions. Supervisor Marcinkowski stated that there were still no bids on the truck. Trustee Graham suggested looking at other ways to sell, such as Ebay. He will also publish again.
